

Osborn, a semi-invalid for years, became seriously ill last October. He spent two months in an Albany hospital, fighting a lung disease. He returned to his plantation nome near here New Year's Day. DEATH CLAIMS CHASE OSBORNE

Dies At Possum Poke Home, Possum Lane

POULAN, Ga., April 12—(AP)— Chase S. Osborn, who rose from a log cabin to Michigan's executive mansion and great wealth, died yesterday.

The tough, 89-year-old political reformer, author and adventurer imally lost his stubborn, five-year battle for health. Death came at his picturesque Possum Poke home in Possum Lane, near Roulan, in Southwest Georgia.

Bride At Side

At his side was his bride of two days, 55-year-old Stellanova Osborn. Mrs. Osborn had been his constant companion for 23 years, first as his secretary, as his adopted daughter for 18 years, and finally as Lis wife. The adoption was voided shortly before their marriage Saturday.

Death was attributed to the after-effects of pneumonia. It was the last of a series of illnesses which plagued the crusty old former governor since 1944.

Wife Kneels

He died at 5:25 p. m. (EST), about two hours after taking a suddent turn for the worse and lapsing into unconsciousness. Close friends said that just before Osborn went into his final sleep, his wife kneeled by his bedside and said:

"I love you."

His last words were:

"I know that, honey. I am well aware of that and you have made me immensely happy."
